

Child Care Restoration Grants Completing Monthly Reporting Round 5 Extension

- 1 Log in to the Gateways Registry website and go into the Director Portal, click CCRG Application card.
- 2 Click on the calculator icon that appears next to your CCRG 2021 grant application. Even though Round 5 funds are in 2022 they are an extension of the 2021 grant.

Child Care Restoration Grant (CCRG) Application

Click the "Apply Now" button below to begin your CCRG application. Applications for the first grant period will be accepted from March 16 through March 31. If you do not see the button it means that your program does not meet the grant eligibility criteria. Please review the eligibility criteria listed in the [Frequently Asked Questions](#) document. You will need to upload some documents with your application.

- **W-9 Form** - Contact your financial advisor/accountant if you have questions. You can download this form from the [IRS website](#).
- **Certificate of Good Standing** - This document from the Illinois Secretary of State's office is required for corporations, partnerships, and limited liability companies (LLCs). It is **not required** for sole proprietors. If needed, you can obtain your certificate of good standing from the [Secretary of State's website](#).
- **Certifications and Requirements / Attestations** - This must be completed, signed, and uploaded with your application. You have two options for this. Complete the editable fields and sign electronically using the steps shown on the last page of the document. Or, print, sign, and scan/take a picture to upload. - 4 Select the month and year you are reporting on in the Month drop-down.
 - Complete the CCRG funds used
 - Your six months' subtotal should equal the check amount received for the grant period
 - You must enter a report for each month Jan - June. If you spent no grant dollars in a month submit the report with zero.

- 5 Click the **"Submit"** button when you are done or, click **"Save & Quit"** to come back to finish that month's report later.

6 The Status column will indicate important information:

- **Draft** – You have started the report and clicked **“Save & Quit.”** You must edit this report and click **“Submit”** before it can be reviewed.
- **Submitted** – You have submitted the report, but it has not yet been reviewed.
- **Information Required** – The report has been reviewed and needs additional information. Check your email for specifics. Click the calculator icon next to that month’s report to edit, if needed.



Child Care Restoration Grants Completing Narrative Reports Round 5 Extension

Narrative reports must be completed once per each grant period. **Before completing the narrative report you must sign the Receipt of Approval letter and scan it/take a picture.** The Receipt of Approval letter will be sent the day your check is mailed with the email stating that your check has been placed in the mail. Please scroll to the bottom to find your letter. If you are the contact listed for multiple locations having checks mailed the same day, you will receive an email with attachments for each individual letter.

For CCRG Extension Round 5 one narrative report will be completed in June. Please save your receipt of approval for uploading in June.


