Course Descriptions (Attachment B)

- Each applicant's work experience is included with the course descriptions. The Committee could
 approve the work experience and course descriptions separately for INCCRRA staff to award if
 eligible. This may result in awarding more credentials between monthly committee meetings.
 - The Family Specialist Credential Committee reviews course descriptions, work experience, and job descriptions separately. After INCCRRA staff update files with courses just reviewed, they can award the FSC to applicants if they meet the education and training requirements.
 - O Question: How would the SAYD Committee know what levels are being awarded?
 - INCCRRA staff can provide an update at the next monthly meeting.
 - After discussion about this process, the SAYD Committee agreed to continue reviewing applicant files as a whole; rather than separately approving course descriptions and work experience.
- Course descriptions were reviewed and assigned SAYD Content Areas.
 - o Recreation, Park, and Tourism Administration (RPTA) courses have some applicability.





 Leisure Services coursework within RPTA was not approved unless it specifically mentioned school-age and/or youth programs and services.
