

Licensed Group Family Child Care Home



Group family child care homes are eligible to be paid \$1,100 for an owner and \$1,100 for each assistant up to 2. The additional \$100 per person is to help offset the cost of taxes/payroll taxes.

In order for the system to correctly calculate your bonus amount, the main provider/owner must be listed with a role of “10 – Group Family Child Care Provider”. Any assistants should be listed with a role of “11 – Group Family Child Care Assistant”. Here are some examples of how to ensure your staff listing is updated so that you receive the full amount you qualify for.

Example 1 – This is a licensed group family child care home with a provider/owner and one assistant. This staff listing is correct because the owner is listed with role “10 – Group Family Child Care Provider” and their assistant is listed with role of “11 – Group Family Child Care Assistant”. This program will receive \$2,200.

Example 3 – This is a licensed group family child care home with the provider/owner listed as “10 – Group Family Child Care Provider”. They have four assistants in the system, all listed as “11 – Group Family Child Care Assistant”. This program will receive \$3,300. The program can use the lump sum bonus amount to pay bonuses as appropriate across employed staff.
