#### **Introducing Birth to Five Illinois**

In 2019, Governor JB Pritzker established an Early Childhood Funding Commission charged with studying and making recommendations on funding goals and funding mechanisms that provide equitable access to high-quality early childhood education and care services for all children birth to age five. The resulting report to the governor and a companion primer made a set of recommendations to ensure all families in Illinois regardless of race, ethnicity, home language, and social circumstance have the services needed to prepare their children for school.



As a first step, Illinois has established an Early Childhood Transformation Team charged with: ensuring early childhood policy is influenced by community voice and data, building a structure for equitable allocation of current and anticipated funding, and making funding stable, predictable, and consistent for early childhood providers. As part of these transformation efforts, the State has also partnered with INCCRRA to develop a Statewide Regional Community Systems infrastructure (now named Birth to Five Illinois!) with the goal of ensuring parent, family, and provider voice is central to the transformation of our Early Childhood Education and Care (ECEC) system.

Birth to Five Illinois's website has officially launched – www.birthtofiveil.com! You can find links/icons to our Facebook, Twitter, Instagram, and LinkedIn at the bottom of any website page, and sign up for our email communications at the bottom of our homepage. Visit the site to meet our growing team and learn more about our goal of creating Birth to Five Action Councils in each of 39 regions, built upon the Illinois State Board of Education (ISBE) Regional Offices of Education (ROE) statewide structure but operating independently. Birth to Five Action Councils will include child care directors, CCR&R staff, parents and families, early learning educators and advocates, school district and municipal officials, and business leaders who will be tasked with identifying and addressing the early childhood service needs in each region.

#### **Child Care Workforce Bonus Registration Deadline**

The Child Care Workforce Bonus program is to recognize the efforts of child care staff who served and continue to serve children and families in person during the pandemic. **Licensed programs and license-exempt centers can apply now through March 11, 2022, to receive a bonus.** Pre-work must be done to update your staff listing within the Gateways Registry Portal before you apply.

#### **Scholarship Funding for Early Childhood Educators**

If you work or have worked in early childhood education and you are interested in getting additional credentials and/or a degree in the field, you may be eligible for an Early Childhood Access Consortium for Equity (ECACE) Scholarship!

Scholarships are still available for this school year (2021-22) at participating Illinois colleges and universities and can cover up to the total cost of attendance after other financial aid is received.

You must be a member of the Gateways to Opportunity Registry and enrolled either full or part-time in a participating Illinois college or university, among other criteria.

NSORTIUM FOR EQUIT The priority consideration date for the 2021-22 ECACE Scholarship application is March 1, 2022. Applications received after that date will be given consideration if funding remains available after all timely, qualified applicants have been awarded.
