
- · Career opportunities in the field

New Division of Early Childhood

In 2019, Governor J.B. Pritzker declared his goal — "To make Illinois the best state in the country to raise young children" — and created the Illinois Commission on Equitable Early Childhood Education & Care Funding. The Commission provided three major recommendations necessary to achieve the Governor's vision:



- 1. Improving programs' quality and equity through the use of a long-term funding goal in early childhood policymaking
- 2. Better-coordinate the funding of such programs, whose resources are currently spread across multiple agencies
- 3. Centralize the administration of these birth-to-five programs in one state agency

To that end, in April 2021, Governor Pritzker announced the creation of a new Division of Early Childhood as part of the Illinois Department of Human Services.

The Division of Early Childhood will strengthen and centralize child care, home visiting, and early intervention services within IDHS through the following core programs:

- · Child Care & Development Fund
- Home Visiting
- Early Intervention
- · Migrant & Seasonal Head Start
- · Head Start State Collaboration Office

Scholarship Funding for Early Childhood Educators

If you work or have worked in early childhood education and you're seeking additional credentials and/or a degree in early childhood education, you may be eligible for the Early Childhood Access Consortium for Equity (ECACE) Scholarship Program. The program was created to address the shortage of qualified early childhood educators by encouraging the pursuit of credentials and advancement of already-held degrees in early childhood education, with an aim toward building a strong, well-prepared workforce. Awards are available for undergraduate study at public and non-profit private 2- and 4-year Gateways-entitled and Early Childhood Access Consortium for Equity member institutions and can cover tuition, books, fees, and other school-related expenses.
