- ECE Levels 2-4 Program Layouts:
  - o Levels 3&4:
    - All necessary coursework is listed.
  - o Level 2:
    - Remove ECE 210 from layout because this course does not primarily assess Level 2 competencies.
    - Financial aid requirements for a full time student are 16 semester hours. There are 20 semester hours (with the removal of ECE 210) listed at Level 2, which means that a student would have to take two semesters before they can attain a Level 2.
      - Suggestion: remove ECE 212 from Level 2 because it is only used to primarily assess IRE1, in which ECE 101 already primarily assesses this competency. This will bring the semester hours down to 16 semester hours, which is more attainable.
  - o Required experience hours are met at all levels.
- Motion to approve (with above changes) for ECE Credential Levels 2-4 made by Jenny Kemp-Berchtold.
