  - Human Growth & Development
  - o Interactions, Relationships, & Environments.
- With the shift to competencies, the Family Specialist Credential Level 2 includes:
  - Human Growth & Development
  - Health, Safety, & Well-Being
  - o Family & Community Relationships
  - o Personal & Professional Development
- Interactions, Relationships, & Environments (IRE) has now shifted to Level 3.
  - O Question: Should IRE be included at Level 2?
    - The Committee agreed that IRE is fundamental knowledge for the FSC.
    - The Committee suggests shifting IRE1 and IRE2 competencies from FSC Level 3 to FSC Level 2.
    - INCCRRA staff will email the competency consultants Johnna Darragh and Nancy Latham with this suggested adjustment.
