Family Child Care Credential Updates

- All Family Child Care Credential Recommendations were passed by PDAC Friday, June 24, 2016.
 - o IDHS will have final sign off and then the FCC Credential will roll-out statewide in July 2016.
- Family Child Care Credential final report has been printed.
 - Each committee member will receive ONE copy.
- 328 applications were received throughout the pilot.
 - o To date 112 Family Child Care Credentials have been awarded.
- Since the pilot closed on March 31, another 33 applications have been received.
 - These applicants will be processed beginning in July.

Review Gateways Family Child Care Credential Portfolios

- Gateways Family Child Care Credential direct route portfolio review (Attachment A)
 - The FCC Credential Committee confirmed that the following applicants have met the requirements of the Family Child Care Credential:
 - DR Applicant 8 approved for FCC Credential Level 4
 - DR Applicant 64 approved for FCC Credential Level 2
 - DR Applicant 116 approved for FCC Credential Level 3
 - DR Applicant 167 approved for FCC Credential Level 3
 - DR Applicant 169 approved for FCC Credential Level 2
 - DR Applicant 267 approved for FCC Credential Level 5
 - DR Applicant 296 approved for FCC Credential Level 4
 - DR Applicant 295 approved for FCC Credential Level 4
 - Note: applicant 295 was a committee member's application. That member was in attendance, but did not vote on the approval.

Next Steps

- Committee will continue oversight of the Family Child Care Credential for the next three years and develop guidelines and requirements for renewal.
- Family Child Care Credential Committee meeting dates for FY17 were discussed.
 - There will not be a meeting in July 2016.
 - o Monthly, one hour telenets will be scheduled and held as needed for FY17.
 - Telenets will continue to be scheduled on the second Thursday of each month from 1:00 PM 2:00 PM.
 - o A Meeting Wizard will be emailed to members to set a face to face meeting for fall 2016.
 - o Committee members will be emailed a list of meeting dates for FY17 by the end of July.
