Overview of Family Child Care Credentials Awarded

- Inclusive of pilot applicants, 344 FCC Credentials have been awarded.
 - 209 – Level 2
 - 57 – Level 3
 - 59 – Level 4
 - 19 – Level 5

Entitled Route Pilot Schools move to Competencies

- All pilot institutions have been asked to renew their Gateways Family Child Care Credential entitlement by December 31, 2018 using competencies.
- The following entitled route pilot institutions have completed an application, submitted syllabi, and realigned their current coursework to competencies.
 - Harper College
 - Approved by FCC Committee on February 8, 2018.
 - Oakton Community College and St. Augustine College
 - All documents have been submitted. Currently working with faculty to make necessary revisions. Once complete, applications will be reviewed by the Entitled Review Group.
 - Rockford University
 - Rockford University has decided not to seek entitlement. There has not been enough interest in this Credential.
 - Applications have not been received from Parkland College and National Louis University.
 - Letters were mailed to notify faculty that if they do not submit an application to align their coursework with the Competencies, their entitlement will end December 31, 2018.

Family Child Care Credential Committee sun-setting/next steps

- This is the final Family Child Care Credential Committee meeting. Sandra Cole shared a timeline **(ATTACHMENT A)** put together by INCCRRA staff, highlighting the work that the FCC Credential Committee has accomplished over the last six years.
 - Thank you to all that have served on this Committee and helped to shape the Family Child Care Credential. A special thank you to Diana Rosenbrock and Sandra Cole for guiding the Committee in this work. Your dedication will long be remembered.
- The Family Child Care Credential Ad-hoc Committee work is concluding, but Committee members will still be a part of the overall Professional Development Advisory Council and Qualifications and Credentials (QC) Committee.
