Family Child Care Credential Updates

- 300 direct route and 28 entitled route pilot applications were received for a total of 328.
 - 99 total direct route and entitled route Credentials have been awarded
 - 3 – Level 5
 - 1 was a Level Advance from Level 4.
 - 26 – Level 4
 - 22 – Level 3
 - 48 – Level 2
- 21 post-pilot direct route applications were received after March 31, 2016 once the pilot closed.
 - These applications will be processed in July 2016 when final FCC Credential requirements are approved.
- Final Pilot Report has been submitted to Marketing for publication.
- Recommendation approval and target dates:
 - FCCC Committee – Approved FCCC Framework, Benchmarks and Level 2 Recommendations on April 9, 2016.
 - QC – Approved FCCC Framework, Benchmarks and Level 2 Recommendations on April 19, 2016.
 - Steering – Approved FCCC Framework, Benchmarks and Level 2 Recommendations on May 18, 2016.
 - PDAC – June 24, 2016 – All FCC Credential Committee members are encouraged to attend. We need your support!
 - IDHS – End of June for statewide roll-out July 2016.
