Approval of March 13, 2017 Minutes

During the Higher Education Forum April 21, 2017, Dr. Paul Busceni presented on Curricular Agility. His presentation focused on ways to increase knowledge and preparation of teachers in early childhood education as well as other settings. Coursework and trainings are being offered with a range of modalities; there have been advancements to online learning as well as blended and hybrid models. Dr. Busceni's presentation highlights the importance of current knowledge needed for online learning. As the Professional Development Advisory Council (PDAC) Qualifications and Credentials (QC) Committee considers how to advance teacher preparation and with online learning rapidly growing, there will be a lot of questions on Curricular Agility.

Presentation—Curricular Agility: Teacher Preparation Redesign for Online Learning (Attachment A)

- Dr. Paul Busceni is the Dean for the School of Education at Kendall College.
 - Licensure and non-licensure programs; including Early Childhood Education.
 - In addition to Attachment A, the following outline below is a summary of Dr. Busceni's presentation.
- Curricular Agility: Teacher Preparation Redesign for Online Learning into three areas:
 - 1. Institutional and Program Culture: Teaching, Learning and Modality:
 - Take an inventory of curriculum.
 - Is curriculum aligned to industry expectations?
 - Is it conducive to being taught online?
 - o T-E-A Method:
 - T = skill is taught (100-200 level).
 - E = skill is expected to be demonstrated (300 level).
 - A = skill is assessed (400 level).
 - Examine attitudes and patterns of faculty.

- Explore various modalities based on student need.
- What are program outcomes?
 - Outcomes are scaffolded and aligned to edTPA.
- What are the program practices?
- We need to move away from "good teachers" to creating "great educators".
 - Be a great educator with a global mindset of teaching and learning.
- Are modalities appropriate for today's students?
 - Good instruction can be adapted to online and distance learning to meet the needs of students.
 - Online learning is flexible and convenient for non-traditional students' teaching and learning.
- 2. Continuous Improvement:
 - What mechanisms are in place to measure progress?
 - Do you have assessments in place?
 - Are your measurements appropriate?
 - What is the overall program response to continuous improvement?
 - Are you using information and data with the correct measure and the correct rubrics to make any necessary changes or improvements along the way?
 - How is the data from program (i.e. faculty, students, and assessment data) used to respond to program focus or vision?
 - How does teaching modality impact curriculum?
 - o Curricular restructuring.
 - o Curricular reconceptualization.
 - New directions.
 - New ideas.
 - New courses.
 - New conversations.
 - o Retirement of some courses.
 - New modalities.
 - Kendall SoE Program Outcomes reflective of edTPA elements.
- 3. Online and Distance Learning:
 - Online and distance learning is increasing.
 - Every level of education, including early childhood, uses online learning.
 - Measures taken to ensure teacher candidates have experience with technology relevant to the profession.
 - Are teacher candidates prepared for the demands of the 21st century learner?
 Teacher candidates must be industry ready in technology as required by the state of Illinois:
 - Describe the measures taken to ensure the candidates gain experience with technology relevant to the profession.
 - (Per 23 Illinois Administrative Code, Part 25, Section 25.120 (a)(5)(B))
 - Excellence in teaching is excellence in learning.
 - Keep your curriculum and yourself fluid and agile.
- Question: Are there some parameters or researched-based practices to teaching online courses?
- Answer: There are necessary benchmark elements to every online course. You need a hook in the
 beginning to get the students engaged early on. Other elements include discussion boards, video
 or typed lectures, assignments, group discussions, video conferencing, etc. to keep students
 engaged throughout the course.

- Question: In regards to student videos what type of platform do you use to upload videos of them working with children?
- Answer: Students usually record themselves on their phones or tablets and upload directly to blackboard. Kaltura is an online video platform designed to help create videos. https://corp.kaltura.com/.

Presentation—Gateways Website Rebecca Livengood

- The Gateways to Opportunity website recently went through a redesign. Visit www.ilgateways.com.
- It is more compatible with smart phones and tablets.
- The redesign includes tiles for each of the top four most popular areas of the website on the homepage:
 - 1. Gateways Registry.
 - 2. Online Training.
 - 3. Training Calendar.
 - 4. Credentials.
- The homepage also includes a scrolling advertisement that can be changed as needed.
 - Committee suggestion: Can this include how many Credentials have been awarded for each Credential? It would be nice to users to see how many Gateways Credentials have been awarded overall.
 - This suggestion will be taken into consideration for future website updates.
- There are tabs across the top for users to prefer to search the website using a more traditional method.

CCDF Requirements to care for Child Care Assistance Program (CCAP) Children:

- To ensure the health and safety of children, the Federal government is now requiring that child care providers - who serve families through CCAP - complete specific health, safety and child development training, have current CPR/First Aid certification, and complete annual training hours.
- According to the Illinois Department of Human Services (IDHS), these requirements apply to both Licensed and License-Exempt providers.
- Required by Sept. 30, 2017:
 - o Gateways Registry Membership.
 - o ECE Credential Level 1 Tier 1 Trainings.
 - DCFS Mandated Reporter Training.
 - CPR/First Aid Certification.
 - o If Director What is CCAP?
- Required by Sept. 30, 2018:
 - o ECE Credential Level 1 Tier 2 & 3 Trainings.
 - Completion of all 3 tiers of the ECE Credential Level 1 trainings leads to the automatic awarding of the Gateways ECE Credential Level 1.
 - Face-to-face and on-line trainings in English & Spanish are available that lead to the ECE Level 1.
- Higher Level Credentials also meet these requirements.
