## **Gateways SAYD Credentials Awarded (Attachment A)**

- With the Committee's guidance through course articulations and reviewing hundreds of SAYD applicant files, INCCRRA staff was able to begin awarding SAYD Credentials internally.
  - o Inclusive of pilot applicants, 270 SAYD Credential Levels 2-5 have been awarded.
  - In 2017, 57 SAYD Credentials have been awarded. With an aspirational goal of awarding 175 Credentials in 2017, we have met 33% of the goal.
  - Since the last SAYD Committee meeting on April 20, 2017, 19 SAYD Credentials inclusive of all levels have been awarded.
- Any applicant file anomalies will continue to be brought to the Committee for review.

# SAYD Marketing and Promotional Strategies (Attachment B & C)

- The SAYD Credential postcard was mailed in February to over 900 Gateways Registry members with SAYD work experience (Attachment B). To promote the SAYD Credential, we could send a second batch.
- The SAYD Credential panel card was distributed to the Child Care Resource & Referral Agencies throughout the state. INCCRRA has stock of this panel card for your distribution.
  - Curtis Peace, Jr. from Illinois Afterschool Network (IAN) can send an email blast with the panel card to all IAN members and conference attendees which may also include strategic partners.
    - Curtis will provide the amount of trainers to INCCRRA staff. Panel cards will be mailed to Curtis upon receipt of this information.
    - INCCRRA staff should contact Amanda McMillan from Illinois Collaboration on Youth (ICOY) to share the panel card.
    - Another option would be to reach out to the Illinois State Board of Education (ISBE).
