#### **Review and Approval of Minutes**

- June 22, 2020
  - Gail Nelson moved to approve the minutes.
  - Marie Donovan seconded the motion.

#### Review of Strategic Plan VIII

- Goals/Objective Left to Achieve in FY 2020.
  - Goal: Develop and disseminate, in collaboration with stakeholders, strategies that support implementation of the comprehensive Gateways to Opportunity Early Childhood Educator Career Lattice
    - The FSC and SAYD Career Lattices were designed and developed this past year.
       IDHS approved with implementation July 1, 2020.
    - The current Illinois Board of Higher Education (IBHE) cohorts are addressing testing of prior learning and engaging high school students through the Gateways to Opportunity Career Lattice.
  - Goal: Analyze effectiveness of various pathways of the Gateways Credentials.
    - Goals might be more difficult to achieve due to COVID-19.
    - The PDG B5 Modularization Project will assist with Higher Education Institutions in organizing courses into discrete packages and assessments of prior learning.
    - WDP should highlight our connections with Tom Layman at GOECD and Carrie Biers at The Ounce to strengthen the connection with the DCFS Licensing Advisory Council.
    - The WDP Committee should discuss how to disseminate successful and innovative practices that come out of the PDG Modularization and IBHE cohorts in spring 2021.
  - Goal: Collect and analyze data evaluating how levers and supports including, but not limited to, Great START and Gateways Scholarship, can be used to strengthen utilization of Gateways Credentials
    - Recommendations were put forward by the Financial Supports Committee and the Workforce Development and Pathway Committee regarding Great START and Gateways Scholarship programs. Recommendations were approved by PDAC and IDHS. The recommendations were effective July 1, 2020.

#### PDG B-5Updates

- Preparing to submit the continuation grant application which is due in October.
  - Credential Waiver
    - Fees have been waived for the ECE, ITC, IDC, FSC, FCC and TA credentials.
    - Close to 2,000 applications have been received since June 2020.
    - More than 600 credentials have been awarded.
    - Demographic information is being collected on those who have applied.

#### Modularization

- Using an RFP the following higher education institutions have been selected to participate in the project: Moraine Valley Community College, Heartland Community College, National Louis University, Northern Illinois University, and Illinois State University.
- Faculty are looking at the ECE Credential and how to build-out virtual and/or online accessible coursework.
- Faculty Fellows and other state faculty will be invited to review work and give input on the work produced.
- Goal is to finish in December for piloting in 2021.

#### Cohorts

- 1.3 million dollars has been distributed among higher education institutions that were selected for their innovative early childhood teacher pathway proposals: Lewis University, National Louis University, Joliet Junior College, Western Illinois University, and Quincy University.
- Grants will support 150 students in the current academic year. Focus is to strengthen and diversify the ECE workforce pipeline.

#### Education Reimbursement

117 eligible applicants have a combined debt of \$214,137. This is an average of 1,830 per person. The 117 individuals will be paid almost 19% of their actual debt.

Illinois Competencies for Early Care & Education Professionals Document – Johnna Darragh Ernst

- Input for the Document
  - The document is designed for both practitioners in the field or who are entering the field.
    - A goal for the document is for a person with limited and/or expansive knowledge of the field can understand the relationship of competencies and credentials within the system.
  - o The document represents a complication of published documents to date.
  - The document has been shared with the PDAC Workforce Development and Pathways Committee and the Steering Committee.
  - Feedback is welcome for additions and revisions of the document.
    - Please send comments to Johnna Darragh Ernst.
  - The Core Knowledge content area has been moved towards the beginning of the document.
  - o It still might be too comprehensive of a document.
    - The alignment with related standards might be something to consider eliminating since it is still on the Gateways website.
  - Johnna will explore the use of the terms Core Knowledge and competencies and how they are being used in the documents.
  - Thinking of the end user, might be useful to use a hyperlink of the appendix.
  - o Could use one-pagers when testing with the field to show the totality of the work.
  - Could use targeted questions to help refine the document.
  - Might want to include a page at the beginning of the document that explains how to read the document.
- McCormick Foundation 1 Page Examples
  - The documents are only an example of what a one-page document can look like as we use the source document to build out infographs or one-pagers for marketing and informational purposes.
